Technique



- ANPR cameras at Entries and Exits
- Vehicles are detected and proof of presence is created automatically
- Cabled or 3G communication to a central server
- Interfaces to P&D and Enforcement back office systems
- Verification tool for error free enforcement







Enforcement process



- Enforcement on Payment and Overstay
- Every visit of vehicle is detected and stored with ANPR image and colour overview image
- Staying time is calculated automatically
- From list of present or visited vehicles a payment list is created
- Hotels: if no payment can be found and vehicle is not on whitelist enforcement record is created through interface to enforcement back office
- Hospital: staying time is calculated for staff and charged directly through salary back office

Current Operations



New Cross Hospital

 Large hospital with parking area for employees. Multiple access. Employees pay for parking their cars. Charging directly through HR department, deducted from salary.

Travelodge

 Hotel chain with private car park. Guests are charged through hotel invoice or pay at P&D terminal. Suppliers and Staff are on whitelist.








New Cross Hospital



- Multiple parking's for public and staff on site
- Desire to introduce payment for parking for staff and in the process to avoid using more barriers and save on operational cost
- Solution SCANaCAR Enterprise. At every entry and exit an ANPR camera
- Staff is charged automatically through payroll for parking expenses made
- Scheme covers suppliers as well, visitors in second phase
