




# EPA Award 2013 - entries now possible

The European Parking Award has been established by EPA as a biennial award for excellence in parking. A prize can be awarded in each of the following four categories

- Category 1 Any newly built car park
- Category 2 Any renovated car park
- Category 3 On-street parking projects



The objective of the awards is to promote qualitative improvements in public car parking both on and off street including contribution of parking policy to Sustainable Urban Mobility Plans. In particular the awards seek to promote improvements in user friendliness, construction maintenance, management, design and safety.

The awards will be presented during the 16<sup>th</sup> EPA Congress in Dublin. Rules and Regulations and entry forms are available at the Secretariat now.

The deadline for entries is January 1<sup>st</sup>, 2013.

The ESPA is a standard for good quality in parking structures. The assessment and presentation of the ESPA awards is in the responsibility of the national parking associations. The checklist is available for download on the website or from the Secretariat. EPAs member associations can order the signs at a price of  $\in$  95,- per piece at the Secretariat. The acrylic plate measures 39,5 cm by 29,5 cm with four stainless steel mounting parts.
