EPA Congress 2011



You still have a couple of days to take advantage of the early bird registration for the 15th EPA congress in Turin in Italy.

The special delegate rate of \in 800,- applies for registration before April 15, 2011. The rate thereafter is \in 900,-. Accompanying partners pay \in 350,- before April 15 and \in 390,- thereafter.

EPA Award 2011 shortlist

The 2011 EPA Award competition sees the highest number of entries ever. A total number of 34 objects were submitted by the operators in all four categories: 16 garages have been entered in category 1: new carpark. Seven renovated objects compete in category 2. Three on-street schemes (category 3) have been entered and eight innovative projects in category 4 apply for an Award. Entries come from 11 countries all over Europe.

In their meeting on April 1st, 2011 the members of the Board have judged the information sent in by the competitors for the European Parking Awards 2011. After a thorough investigation and a long discussion the board nominated the following car parks for the shortlist:

The shortlisted objects will be visited and inspected by the jury: Antonio Cidade Moura (chairman), Bernd Beer, Jordi Bonet, Jean-Jaques Decaesteke and Peter Martens (secretary) in the week from May 23-27, 2011. The Awards will be announced and presented by the president of the EPA at the 15th EPA congress to be held from September 14 to 16, 2011 in Turin, Italy.No information about the winners will be announced prior to the congress. All entrants will be featured in the upcoming three editions of Parking trend international.

EPA general meeting and elections September 16, 2011

This year's general meeting takes place in Turin, Italy on the occasion of the 15th EPA congress on September 16, 2011 from 14.30 to 16.30. Elections will be held for the following positions:

EPA president - currently Nick Lester (term of office: two years)

Two board members - currently Laurence A. Bannerman and Antoni Roig (term of office: two years each)

Board member as replacement for the position of Philippe Princet (term of office: one year).

Also the six members of the Policy and Strategy Committee will be elected. The invitation and agenda together with the explanation regarding the votes and nomination will be sent out to all EPA member associations in May 2011.

ESPA 2011



The European Standard Parking Award demonstrates that the carpark awarded fulfils certain standard criteria with respect to safety and customer services.

EPA has delegated the assessment and presentation of the ESPA-awards to the national parking associations. Signs with 2011 are at stock and can be ordered for €95,- a piece at the EPA Secretariat. The Guidelines are available for download from www.europeanparking.eu or from the Secretariat.

EU white paper on transport policy published

On March 28, 2011 the European Commission published the white paper: Roadmap to a Single European Transport Area - Towards a competitive and resource efficient transport system. This roadmap sets out 40 concrete initiatives for the next decade. The aims are to build a competitive transport system that will increase mobility, remove major barriers in key areas and fuel growth and employment. A white paper is a document containing proposals for European Union action in a specific area. The White paper is the last stage before the proposals it contains are send to the European Parliament. Task Group Data Collection

The data collection project is an ongoing task, the results are continuously refined. New figures are available for Germany now: The initial estimate from September 2010 was based on the Swedish data (since only information from 5 German cities was available); now 42 cities were taken into account which makes the overall estimate more precise. The new estimate shows a total number of 3.4 Mio parking spaces in Germany. The work on the data collection carried out so far will be audited by the University of Barcelona and further research will be undertaken.

Task Group Image

The group prepares texted arguments addressed for various target groups: consumers, politicians and other stakeholders. Results will be presented at the EPA congress in Turin.
