Interested speakers are invited to submit abstracts for presentations on research, policy developments and innovative practices related to the field of parking. The presentations should not exceed 15 to 20 minutes. Commercial presentations will not be accepted. The abstract must relate to any of the following topics

### Instructions to submit an abstract for the 18th EPA Congress:

The final date for submissions of the abstract (min 500 words) and a short biography is **28**<sup>th</sup> **February, 2017.** The abstracts must be PDF documents.

Each submitted abstract must be ideally in English, must not exceed two pages, and must include:

- Name / Address / Phone Number / Author E-mail
- General topic of the abstract (example: "Park and Ride")
- Name your abstract file as follows: 2017 EPA Congress Your surname the stream the topic.
  Example: "2017 EPA Congress –Smith Stream A Park and Ride"

#### **Call for Abstracts: Schedule**

- February 28<sup>th</sup>, 2017: Abstract submission deadline.
- March 2017: Review by Steering Committee and selected authors invited to submit draft papers.
- June 1<sup>st</sup>, 2017: Draft paper submission and Steering Committee completes reviews within the month.
- July 31<sup>st</sup>, 2017: Final paper/presentation submission deadline.

### **ESPA On-Street - Test phase prolonged**

The **On-street European Standard Parking Award** (ESPA On-Street) is currently being established by the European Parking Association as an award for excellence in on-street parking regulation systems.

The award ensures the quality of service in regulated on-street **controlled parking zones** by establishing a set of minimum standards for a good basic quality in the system and its services.

To make the award accessible for all types of regulation systems, the preliminary test is now open for those organizations/institutions that want to apply for the ESPA On-Street Award. EPA will review the assessment forms and questionnaires received from all participants to make the award better.



EPA will then formally approve the new standard which will be introduced at the <u>18th EPA congress</u> in Rotterdam, September 20-22, 2017.All materials are available for <u>download on the EPA website</u>.

### **ESPA and ESPA Gold**





The European Standard Parking Award ESPA is a standard for good quality in parking structures. ESPA Gold is for those car parks with high levels of customer services and comfort. Each national member association in the EPA independently organises to award the standard to the operators or owners of the parking facility. The member associations may order the acrylic signs including mounting parts for 200, - € per piece and are asked to inform the Secretariat which car park has been awarded.

To obtain the award the EPA provides a comprehensive excel checklist for download on the EPA website www.europeanparking.eu together with a manual to fill in the list. Members and operators are encouraged always to use the version provided on the website.
