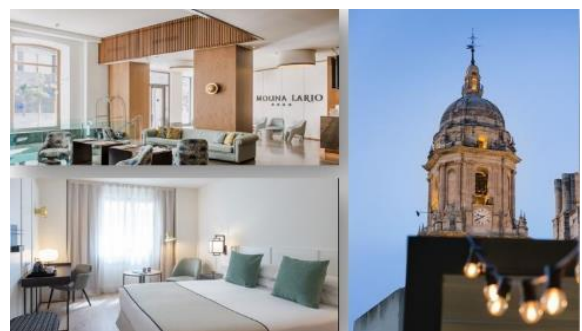

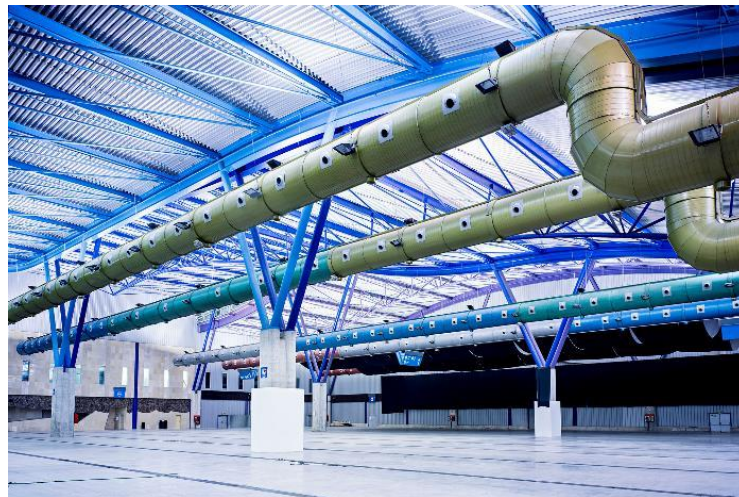

The member associations may order the acrylic signs at the EPA Secretariat including mounting parts for 200,- € per piece and are asked to inform the Secretariat which car park or on-street scheme has been awarded.

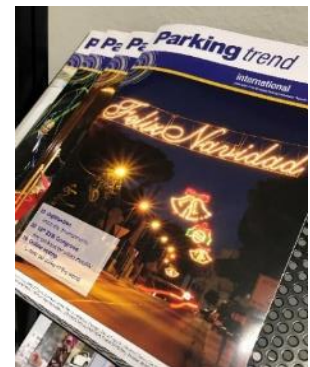
